#### Subject: Household Income Limits, and High Need Household-Maximum Annual Incomes

Reference: Ontario Regulation 370/11 and subsection 40 of the Housing Services Act 2011

## Background:

Under Section 40 of the Housing Services Act 2011, the Services Manager must ensure that rent-geared to income assistance (RGI) is provided in the service area of the Nipissing District for,

- a) At least 1,522 households whose income is no greater than the prescribed income limits (HIL's); and
- b) At least 807 of high need households.

For the purpose of defining local service levels, Household Income Limits for RGI applicants/tenants and maximum annual incomes for high needs households are provincially

prescribed under Ontario Regulation 370/11 where "household income" means the sum of all payments of any nature paid to or for the behalf or for the benefit of each of the members of the household during a 12-month period.

The Centralized Housing Waiting List and Housing Providers apply HIL's as eligibility criteria during the application process for RGI assistance, for monitoring continuous RGI eligibility for tenants, and for annual statistical reporting to the Service Manager.

Housing Providers apply maximum annual income for hight need households to determine how tenants fall into this categoryunder a standard annual statistical form.

<u>On January 1, 2024</u> new household income limits for RGI and high need households have come into effectunder Ontario Regulation 370/11 and subsection 40 of the Housing Services Act, 2011.

### Action:

To ensure compliance with provincially prescribed service levels for RGI assistance, the Centralized Waiting List and Housing Providers must utilize the following Housing Income Limits and Maximum Annual Income for RGI administration and reporting <u>related to January 1</u>, <u>2024 to December 31, 2024.</u>
